Village of The Branch – Board of Trustees Meeting April 12, 2022 Track #48

The monthly meeting of the Village of The Branch was held at 40 Route 111, Smithtown, NY, seven thirty p.m. on April 12, 2022. Mayor Delaney, Trustees Carro, Botto, Ryan, Damm, Building Inspector Arico, Village Attorney Ring, Treasurer Mequia, and Village Clerk Cozine were present.

Mayor Delaney called the meeting to order at 7:43 pm with the pledge of allegiance.

Trustee Carrro made a **motion** to accept the March 2022 Board of Trustees minutes and mayor Delaney seconded the **motion**. All are in favor, approved unanimously.

Trustee Carrro made a **motion** to accept the April work session 2022 Board of Trustees minutes and Trustee Botto seconded the **motion**. All are in favor, approved unanimously.

Treasurer's Report

Treasurer Mequia reported that:

- Received delinquent tax payment for 32 Hemlock
- Received audited financials for Year Ended 2021

Trustee Carro made a **motion** to accept the treasurer's report as submitted and direct treasurer to pay all the bills on Abstract #2183 totaling \$28,456.85. Trustee Botto seconded the **motion** which was approved unanimously.

Mayor Delaney made a **motion** to open the Public Hearing to discuss the 2022-23 Budget. Trustee Carro seconded the **motion**. All are in favor, approved unanimously.

Mayor Delaney is going to meet with the NY Senators to see if he can secure some more grant monies to help defer the cost of the project.

Trustee Botto made a **motion** to close the public meeting. Trustee Carro seconded the **motion**. All are in favor, approved unanimously.

There was nobody from the public present. Mayor Delaney mentioned that Treasurer Mequia made all the adjustments that were spoken at the work session. The only thing that didn't come up was discussion of sumps. We can always move funds around to handle that. Also, if we have extra monies, we can use it for that. Trustee Ryan suggested we should check the Village trees to assess.

Mayor Delaney made a **motion** to approve the budget as is. Trustee Carro seconded the **motion**. All are in favor, approved unanimously.

Mayor Delaney made a **motion** to open the Public Hearing. Trustee Carro seconded the **motion**. All are in favor, approved unanimously.

Treasurer Mequia added that we finished paying off the bond that was used for Village Hall renovations.

Attorney Ring's Report

Attorney Ring reported that:

- Received \$1600 check from BBCG Landscaper regarding the underground electric breaks at 3 Spruce Court for repayment of damages.
- Sent letter to Nextdoor.com on March 8, 2022
- Mayor Delaney asked how long doe sit take to get someone evicted? Attorney Ring said approximately 2 years.

Building Inspector's Report

Building Inspector reported that:

- Issued 3 new permits,1 sign permit, issued 3 C/O, and 19 inspections
- Met with Ace Hardware about sidewalk permit to do BBQ demos with food
- Mayor Delaney wants to start to charge for outside eating permits since this is not COVID related anymore.
- Sign permit fee analysis will send via email to the Board.

Mayor Delaney made a **motion** to advertise for increase in sign permit fees and BZA fee. Trustee Carro seconded the **motion**. All are in favor, approved unanimously.

Mayor Delaney made a **motion** to approve the Court Audit for year ending 2021. Trustee Carro seconded the **motion**. All are in favor, approved unanimously.

Trustee Botto made a **motion** to allow the Treasurer to make advance payments when necessary to avoid late fees or fines. Trustee Carro seconded the **motion**, which was approved unanimously.

Trustee Botto made a **motion** to allow the Treasurer and/or Mayor to be the sole signature on checks. Trustee Carro seconded the **motion**, which was approved unanimously.

Trustee Botto made a **motion** to allow attendance at NYCOM/ SCOVA meetings. Trustee Carro seconded the **motion**, which was approved unanimously.
