Mayor Delaney made a **motion** to appoint Patricia Weingrow & Mary Coccurullo as Election Inspectors for 2017 Election, to be paid at rate of \$125 per day. Trustee Botto seconded the motion, which was approved unanimously.

Trustee Albrecht made a **motion** to close the meeting. Trustee Donnelly seconded the motion, which was approved unanimously. The meeting was adjourned at 9:30 pm.
