### Village of The Branch – Board of Trustees Meeting April 11, 2023 Track #67

The monthly meeting of the Village of The Branch was held at 40 Route 111, Smithtown, NY, seven thirty p.m. on April 11, 2023. Mayor Delaney, Trustees Botto, Ryan, Damm, Attorney Ring, Treasurer Mequia, Building Inspector Arico and Village Clerk Cozine were present.

Mayor Delaney called the meeting to order at 7:37 pm with the pledge of allegiance.

Trustee Botto made a **motion** to accept the March 2023 Board of Trustees minutes and Trustee Damm seconded the **motion**. All are in favor, approved unanimously Trustee Damm abstained since was not present at March meeting.

Trustee Botto made a **motion** to accept the April 2023 Board of Trustees work session minutes and Trustee Damm seconded the **motion**. All are in favor, approved unanimously, Trustee Ryan abstained since was not present at the April meeting.

### Treasurer's Report

Treasurer Mequia reported that:

- Received \$12,334.79 Mortgage Tax check from Suffolk County for quarter end Dec 31, 2022
- Justice Court numbers are up to date on prelim budget.
- Transferred remaining \$9800 to parks fund that was the difference in what we received from the \$49,000 grant for Old Rte. 111
- Printed out updated proposed budget.
- Have 2 estimates for the tax program.

Trustee Botto made a **motion** to accept the treasurer's report as submitted and direct treasurer to pay all the bills on Abstract #2195 totaling \$11,945.06. Trustee Ryan seconded the **motion** which was approved unanimously.

Trustee Botto made a **motion** to reopen the public hearing for James Ewart III, 9 Branch Drive. Trustee Damm seconded the **motion**. All are in favor, approved unanimously.

Mr. Ewart – told the board he has interviewed many contractors and received a lot of estimates and receiving conflicting suggestions on what to do with the house. Contractors told Mr. Ewart that the house was in pretty good shape and preserved despite all the water that was put on the fire. Mr. Ewart has retained an expediter to make the process easier and quicker. He said he could have a letter from the contractor next week. Mr. Ewart still has not decided whether he is going to fix the house or sell the house. At this point Building Inspector Arico explained and told Mr. Ewart that you need signed contract from an architect and architectural drawings before you need a contractor. Told him he has **2 weeks** to get this done or the Board will move forward. Once you have the plans, bring them in and you can get the permit. Mr. Arico asked what exactly did the contractor tell him? Mr. Ewart responded he needs to gut the house down to the beams; the deck needs to come off. Trustee Botto reiterated that you had 6 years to take care of this and its frustrating to us and the neighbors that it hasn't been done yet.

Attorney Ring said he wants something in writing so that Mr. Ewart understands what he needs to do and will be waving his rights if he doesn't follow through in 2 weeks. Mr. Ring asked for his email address since he has been reluctant to give the Board his mailing address. He responded with 2 email addresses. Jimewart3@gmail.com and James.ewart@anheuser-busch.com

Mr. Ewart asked the building inspector if the sanitary system get effected in the demo and he said no. Mr. Arico said he needs a rodent letter, an asbestos abatement letter and a water and electric disconnect letter from the utilities companies if he intends to demo the house. Mr. Ewart said he will proceed aggressively and wanted to know if he needs a permit for a POD. The Board answered that he needs a permit for one of them and it lasts for 60 days.

The Board said they want a letter stating when he is starting his demo or rebuild and he has until April 27<sup>th</sup> end of day to respond otherwise, they will proceed with their demo of the house.

Mayor Delaney made a **motion** to adjourn the public hearing until May 9<sup>th</sup> 2023. Trustee Ryan seconded the **motion**. All are in favor, approved unanimously.

## Attorney Ring's Report

Attorney Ring reported that:

- Gave Treasurer Mequia information on Hewlett Neck Audit about Clerk doing Treasurers duties.
- Received the retainer for investigative services.
- Landscape contract first renewal expires June 30<sup>th</sup> 2023.
