#### Village of The Branch – Board of Trustees Meeting June 13, 2023 Track #70

The monthly meeting of the Village of The Branch was held at 40 Route 111, Smithtown, NY, seven thirty p.m. on June 13, 2023. Deputy Mayor Carro, Trustees Damm, Ryan, Attorney Ring, Treasurer Mequia, Building Inspector Arico and Village Clerk Cozine were present.

# Treasurer's Report

Trustee Damm made a **motion** to approve Harris tax program Trustee Ryan seconded the **motion**. All are in favor, approved unanimously.

Trustee Ryan made a **motion** to accept the treasurer's report as submitted and direct treasurer to pay all the bills on Abstract #2197 totaling \$. Trustee Damm seconded the **motion** which was approved unanimously.

Trustee Ryan made a **motion** to open the public hearing for Local Law #3 of 2023. Trustee Damm seconded the **motion**. All are in favor, approved unanimously.

Deputy Mayor Carro read the proposed local law as follows:

Local Law No. 3 of 2023

Village of The Branch, County of Suffolk

260-10 Parking in Commercial Areas.

A (5). No person shall park or leave standing a motor vehicle within 10 feet of a Fire Hydrant, fire well cistern, or Fire Department connection or apparatus.

260-11 Parking in Residential Areas.

E. No person shall park or leave standing a motor vehicle within 10 feet of a Fire Hydrant, fire well cistern, or Fire Department connection or apparatus.

This local law shall take effect immediately upon filing with the Secretary of State.

There was no comment from the audience.

Trustee Damm made a **motion** to close the public hearing for Local Law #3 of 2023. Trustee Ryan seconded the **motion**. All are in favor, approved unanimously.

Trustee Damm made a **motion** to approve Local Law #3 of 2023 – 260-10 Parking in Commercial Areas. Trustee Ryan seconded the **motion**. All are in favor, approved unanimously.

Trustee Damm made a **motion** to open the public meeting. Trustee Ryan seconded the **motion**. All are in favor, approved unanimously.

Trustee Damm made a **motion** to close the public meeting. Trustee Ryan seconded the **motion**. All are in favor, approved unanimously.

- Received 2 bids for lighting improvements to Old Route 111 path: NY Trenchless \$9,400 and Schumacher \$13,400.

- Court recap 3 no shows found in default, 2 adjourn to Sept, 4 guilty, 2 no shows to be rescheduled to August.
