# Village of The Branch – Board of Trustees Meeting July 11, 2023 Track #71

The monthly meeting of the Village of The Branch was held at 40 Route 111, Smithtown, NY, seven thirty p.m. on July 11, 2023. Mayor Delaney, Trustees Carro, Botto, Damm, Attorney Ring, Treasurer Mequia, and Village Clerk Cozine were present.

Mayor Delaney called the meeting to order at 7:34 pm with the pledge of allegiance.

Trustee Carro made a **motion** to accept the June 2023 Board of Trustees minutes and Trustee Damm seconded the **motion**. All are in favor, approved unanimously. Trustee Botto and Mayor Delaney abstained as they were not present for the meeting.

### **Attorney Ring's Report**

Attorney Ring reported that:

- Local Law #3 sent to the State.
- Leaf and Brush bid due July 25.
- Lighting renewal has been executed already.
- Sent renewal to snow contractor but haven't received back yet.

Mayor Delaney mentioned things are moving along with 9 Branch and will have him come back for the October meeting.

### **Treasurer's Report**

Treasurer Mequia reported that:

- Taxes went off nicely and smoothly.
- 86% of taxes are collected at this point, almost \$639,000.
- Collected mortgage tax through March 2023.
- Sign permits will go out next month.
- The tax program needs another name as a project leader and Mayor Delaney volunteered his name.

Trustee Carro made a **motion** to accept the treasurer's report as submitted and direct treasurer to pay all the bills on Abstract #2198 totaling \$75421.05. Mayor Delaney seconded the **motion** which was approved unanimously.

Trustee Carro reported that:

- Court recap 10 culprits, 2 no shows guilty by default, 4 guilty, 2 no shows to be rescheduled to August.
- ChargeSmart EV is just going to do Village Commons shopping center currently. Will be coming to August PB, cancelled July since won't have site plans done in enough time.
- Need to inform LIPA we put in 6 new light and added 2 new poles.

- "Stop sign is coming" sign in front of #2 Dogwood was hit and needs to be put back up. Trustee Botto noted that and put on list.
- Matching caps on Gappsi wall that was fixed from car accident involving Amazon truck should be done this week.

- Hemlock paving is done.
