# Village of The Branch – Board of Trustees Meeting August 8, 2023 Track #73

The monthly meeting of the Village of The Branch was held at 40 Route 111, Smithtown, NY, seven thirty p.m. on August 8, 2023. Mayor Delaney, Trustees Botto, Damm, Building Inspector Arico, Treasurer Mequia, and Village Clerk Cozine were present.
